

Terms and Conditions – Queenstown Winter Sales Promotion (“Promotion”)

1. Information on how to enter the Promotion and the Prize available form part of these terms and conditions. Any entry not complying with these terms and conditions is invalid. Entry into the Promotion is deemed acceptance of these terms and conditions.
2. The Promoter is Motor Trade Finance Limited (“MTF”) at Level 1, 98 Great King Street, Dunedin (“Promoter”).
3. Entry is open to people who:
 - a. are residents of New Zealand aged 18 years and over; and
 - b. take out a new loan with MTF within the Promotion Period
 (“Customers”)
4. Employees, directors and shareholders of and dealers and sales agents associated with: (a) the Promoter; (b) the Promoter’s associated companies; (c) the Promoter’s dealers and franchisees; and (d) the Promoter’s agencies associated with this Promotion, and members of their immediate families are ineligible to enter the Promotion.
5. The Promotion commences at 9:01am on Tuesday 1 June 2021 and closes at 11:59pm on Thursday 30 September 2021 (“Promotion Period”). Entries received after this time will be ineligible for entry.
6. Entry is limited to once for each new loan taken out by a Customer during the Promotion Period. For the avoidance of doubt, a Customer will be entered into the Draw each time the Customer takes out a new loan with the Promoter during the Promotion Period.
7. The Promoter reserves the absolute discretion to request the Winner to produce proof of identification and proof of residency in order to claim the Prize.
8. From all eligible entries deemed to be received in accordance with clause 19 below, one (1) Prize winner (“Winner”) will be chosen in a random draw of eligible entrants conducted at Level 1, 98 Great King Street, Dunedin on Monday 4 October 2021 (“Draw”). The odds of winning depend on the total number of eligible entries received.
9. The Prize will be awarded as follows:

One (1) prize consisting of the Winner’s choice of the following, subject to clause 10 (valued up to \$5,000) (“Prize”):

 - a. **Adventure** (for 2 adults) –Skyline Queenstown Gondola + 3 Luge rides (2 adults), Zip Trek Kea Tour (2 adults), Hydro Attack Individual Shark Ride + USB (2 adults), 2 nights’ accommodation at the QT Queenstown (2 adults), return regional seat and bag airfares flying Air New Zealand into Queenstown for 2 adults.
 - b. **Luxury** (for 2 adults) – Onsen Pools (Serenity Soak & Spa (includes 45min soak & 1 hr massage for 2 adults), 2 nights’ accommodation at QT Queenstown (2 adults), return regional seat and bag airfares flying Air New Zealand into Queenstown for 2 adults.

- c. **Family** (for 2 adults and up to 3 children) – Skyline Queenstown Gondola + 3 luge rides (family pass), Real Journeys Walter Peak Farm Visit (2 adults & up to 3 children), Accommodation (2-3 bedroom apartment (sleeps up to 5), return regional seat and bag airfares flying Air New Zealand into Queenstown for up to 5 people.
10. If the Winner lives in the Southland or Otago region, the Prize will not include airfares, but rather an alternative Queenstown activity or experience will be included in the Prize, such activity or experience and the value thereof to be chosen by the Promoter in the Promoter's sole discretion. A Winner living in the Southland or Otago region will be responsible for transport and associated costs to Queenstown.
11. In the event that there are an insufficient number of eligible entries, the Promoter reserves the right not to award the Prize.
12. The Prize is not transferable or exchangeable and cannot be redeemed for cash.
13. The Winner will be notified by the Promoter or its agent by telephone, email or mail in accordance with the contact details the Winner provided during entry into the Promotion. If a Prize remains unclaimed by 5.00pm on Monday 18 October 2021, despite the Promoter's reasonable endeavours to contact the Winner, the Prize will be forfeited and the Promoter may conduct an unclaimed random draw at the same place as the original Draw on Tuesday 19 October 2021 in order to award any unclaimed Prize. The first valid entry drawn will win the Prize.
14. The Promoter is not liable for any loss or damage whatsoever including (but not limited to) indirect or consequential loss, or personal injury suffered or sustained during the course of accepting, using or consuming the Prize, except for any liability which cannot be excluded by law.
15. The Promoter's decision is final and no correspondence will be entered into.
16. All flights, accommodation and activities that form part of the Prize will be booked through Orbit Travel, Dunedin. The Prize must be used by 31 October 2022 and all bookings are subject to booking and flight availability.
17. The Winner will be responsible for any travel documentation required, transport and associated costs from their residence to the nearest regional airport that Air New Zealand operates from, all other expenses related to the Prize including any taxes, travel insurance, transfers, spending money, food beverage and any other incidental costs.
18. All air travel will be subject to Air New Zealand's Conditions of Carriage, to view visit www.airnewzealand.co.nz/conditions-of-carriage.
19. If for any reason this Promotion is not capable of running as planned, whether caused by infection by computer virus, mobile phone failure, line drop out, bugs, tampering, unauthorised intervention, fraud, technical failures or any other cause beyond the control of the Promoter which corrupt or affect the administration, security, fairness or integrity of the Promotion, the Promoter reserves the right in its sole discretion, (subject to any written direction given by a relevant regulatory authority), to cancel, terminate, modify or suspend the Promotion. The Promoter may in its sole discretion disqualify any individual who tampers with the entry process.
20. An entry is deemed to be received at the time of loan creation within the Promotion Period. The Promoter is not responsible for receipt of incorrect, inaccurate or incomplete information caused by an entrant or resulting from defective data transmission. The Promoter is not responsible for any problems or technical malfunction of any telephone, telephone or computer network, or lines, servers, or telephone or internet providers, traffic congestion on any phone or computer network, or any combination thereof, including any injury or damage to participants

or any other person's handset or computer related to or resulting from participation or sending or receiving of any communication or of any materials in this Promotion.

21. If an entrant receives an arrears notice from the Promoter during the Promotion Period, that entry will be disqualified and will no longer be deemed to be an eligible entry able to take part in the Draw.
22. Once the Promoter has contacted the Winner and confirmed that he or she is an eligible entrant and that he or she agrees to these terms and conditions, his or her name will appear on the Promoter's website at www.mtf.co.nz. Upon acceptance of the Prize the Winner agrees to their name being published online and in print, or in any other media by the Promoter for information and promotional purposes, without payment or compensation to the Winner, except where prohibited by law.
23. The Promoter may wish to document the Winner redeeming the Prize and after they have accepted the Prize. The Winner agrees to participate in these and any other publicity arrangements that the Promoter may reasonably require. The Winner agrees to the use and publication of photographs and videos of them by the Promoter through various channels including but not limited to the Promoter's website and social media accounts. The Promoter reserves the right in its absolute discretion to vary or add to these publicity arrangements at any time without notice to the Winner.
24. The Winner may not designate someone else as a Winner. If the Winner is unable or unwilling to accept the Prize, the Promoter may award it to an alternate Winner by conducting an unclaimed random draw at the same place as the original Draw on Tuesday 19 October 2021 in order to award the unclaimed Prize. The first valid entry drawn will win the Prize.
