The Promotion commences on **1 March 2025** and ends on **31 May 2025** (“**Promotion Period**”).

Promoter

The MTF Fiji cruise promotion (“**Promotion**”) is conducted by Motor Trade Finance Limited (“**MTF**”), Level, 1, 98 Great King Street, Dunedin, and supported by World Traveller NZ (“**Promoters**”).

Eligibility

Entry is open to people who:

- a. are residents of New Zealand aged 18 years and over;
- b. are new or existing customers who apply (and are approved) for a new loan with MTF within the Promotion Period;

All loans are subject to lending criteria and responsible lending checks.

Employees, directors, and shareholders of and dealers and sales agents associated with: (a) the Promoters; (b) the Promoter’s related companies; (c) the Promoter’s dealers and franchisees; and (d) the Promoter’s agencies associated with this promotion, and members of their immediate families are ineligible to enter the Promotion.

Conditions of entry

Entry is limited to once for each new loan taken out by a customer during the Promotion Period.

The Promoters reserves the absolute discretion to require any winner to produce proof of identification to claim the Prize.

Winners must depart from Auckland, Wellington or Christchurch only.

Transfers and meals are subject to additional expense unless specified as included. Personal expenses during travel not included, World Travellers and Blue Lagoon Cruises, usual conditions apply.
